**BACKGROUND:**

**IMPROVING THE PRODUCT IDENTIFICATION IN CB TEST REPORTS**

The CMC noted that the CTL could not present a significant suggestion to improve the product identification by the Recognizing NCBs and that samples are often requested by NCBs because they want to make sure that the sample(s) submitted for their approval has had no changes from the samples that were used by the NCB "A" to grant the CB Test Certificate.

The CMC also noted the Industry representative of the Canadian delegation's statement whereby the provision of a Factory Audit/Inspection Report together with the CBTC and CBTR would significantly improve the level of recognition by NCB "Bs".

The CMC agreed with the Chairman proposal that to properly understand the mechanisms that are required to increase the "recognition" and that the IECEE Secretariat will circulate a questionnaire to the Members' NCBs, essentially asking whether they request sample(s) while processing the "recognition" of CBTC and what they think is needed in addition to the CB Test Certificate and CB Test Report to increase their confidence, thus avoid asking for sample(s) and improving the recognition timeframe.

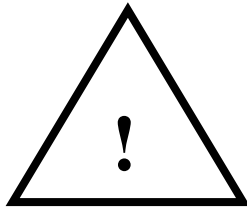
